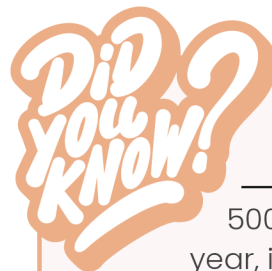
Post-Abortion Healing Retreats

We are excited to share that we will soon be launching Post-Abortion Healing Retreats, designed to bring deep restoration and freedom to women who have quietly carried the pain of a past abortion for many years.

We are currently equipping volunteers and coordinating efforts with church support to provide at least two, 3-day retreats in 2026. The retreats will be held in a private location, in a peaceful setting along the Oregon Coast, offering a purposeful and dedicated time for Christ-centered healing.

At this time, retreats are designed for women who may be faithfully attending church, raising families, and serving others, all while silently bearing unresolved grief, shame, or secrecy. Through guided teaching, prayer, and a trusted post-abortion healing curriculum, women will be equipped with tools to fully receive the forgiveness of Jesus and begin a journey of lasting freedom.

We believe the impact will extend far beyond the retreat itself. As women experience healing, they are often empowered to lead, advocate, and serve with renewed passion. The ripple effect will be felt for years to come as stories of pain are transformed into testimonies of redemption and hope.



On average, a baby uses 50–70 diapers and 140–210 baby wipes per week!

500 mentoring appointments were attended last year, in which moms and dads learn vital parenting education. Parents have an opportunity to earn 30 diapers a week and 150 wipes. Supreme Court Hears Donor Case

On December 2, 2025, the U.S. Supreme Court heard oral arguments in *First Choice Women's Resource Centers, Inc. v. Platkin*, a case involving a New Jersey Attorney General subpoena for extensive internal records, including the names of donors. The New Jersey Attorney General issued the subpoena as part of a state investigation into whether First Choice, a pregnancy clinic like You Medical, misled donors and clients about its services. First Choice challenges the subpoena as overly broad and argues that the demand for donor information and other internal documents violates its First Amendment rights of free speech and association. The case also raises a procedural question about whether federal courts must defer to state court proceedings before adjudicating constitutional challenges to state investigatory demands.

While a decision is expected by the summer of 2026, the case is crucial to protecting pregnancy centers and their donors from bullying legislation that intends to reduce support to pregnancy centers.
